I hereby confirm my booking for one service during the 20__ breeding season to the ____ stallion _____ ApHC Reg. # _____ for the Mare _____ Reg # _____ (AQHA/ ApHC)

Such confirmation is based upon our agreement as follows:

1. Payments due from mare owner

- (a) Service fee shall be \$_____. Booking fee of \$_____. Balance \$_____ payable when mare arrives at the ranch for breeding.
- (b) Boarding fees shall be \$_____ per day wet mare \$_____ dry.
- (c) Mare owner is responsible for payment of Veterinarian Bills before mares leaves the ranch.

2. Health and condition of mare

- (a) Mare owner agrees that mare shall be healthy and in sound breeding condition with a negative culture. Maiden mares may not be required to be cultured at the stallion owner's discretion. The stallion owner may request certification by a veterinarian before mare is bred. It is understood that the stallion owner may have their own veterinarian check mare for normal breeding condition. Mare owner will be consulted before any extensive veterinary treatment is given if it should be necessary.
- (b) If shod, mares to be bred must have their hind shoes removed before mare arrives at the breeding facility

3. Health and condition of Stallion

If stallion should be sold, die or become unfit for service before mare is bred, this contract shall become null and void and the booking fee shall be returned.

4. Accident or injury to mare, foal or stallion

Owner or manager of stallion and ranch and their representatives agree to act with all due diligence and to exercise every precaution in the breeding and care of mare and her foal. However, the owners of the ranch or stallion shall not be liable or responsible for disease, accident or injury to the mare. The owner of the mare shall not be liable or responsible for any accident of injury to the stallion or for disease.

5. Live Foal guarantee

- (a) Stallion owner agrees to guarantee a live foal (that stands and nurses without assistance after foaling). This guarantee applies only if stallion owner is notified in writing within one week following death of foal, which notice must be accompanied by a statement by a licensed veterinarian.
- (b) In the case of a mare aborting or absorbing the fetus in earlier pregnancy, a statement by a licensed veterinarian the mare is not in foal and that it was not caused by negligence of the mare owner shall be required.
- (c) In the event no live foal results from the breeding, Mare Owner has the option of breeding the Mare the following breeding season, only on the same terms and conditions set forth herein. Substitutions are at the discretion of the Stallion owner.

6. Breeding certificate

Breeding certificate shall only be issued when service fee is paid in full and mare has been vet checked in foal. Blue copy from Appaloosa Horse Club shall be mailed upon the birth of the foal.

7. General provisions

- (a) Should mare owner fail to deliver mare for breeding on or before _____, the stallion owner or manager shall be under no further obligation with respect to any matter set forth herein.
- (b) This contract shall not assigned or transferred by mare owner.
- (c) A photocopy of the Mare's registration papers, showing both sides, must be furnished and returned with this contract
